1. The meeting was called to order.

**2. Minutes**

A motion was made by Member Nicholson and seconded by Member Schepp to approve the minutes of August 24, 2022. The motion passed unanimously.

**3. Old Business – No Old Business**

**4. New Business**

Chief Crowell gave a brief presentation on the proposed Flock camera system.

The committee asked questions about the system and how it would be used. The Flock camera system has been awarded through a grant program and would be installed in the Village of Fayetteville.

The Committee asked questions and discussed the Flock camera system. The committee asked many questions about the data that would be collected and how that data would be protected. The committee asked questions about any audio component of the system and if it would be used.

The Chief stated that if the camera system was approved, he would share the policies and procedures that will be created for the use of the system.

Member Schepp & Member Pilewski offered support for the camera system.

Chairperson Waters asked that each of the Village representatives go back to their municipalities and provide them with the information presented and get feedback.

**5. Chief's Report**

- Chief Crowell stated that the 4 new recruits are doing well in the academy and there are 3 officers in field training.

- Chief Crowell stated that the department is down 4 officers.
- Chief Crowell stated that the 10 Hour Shift proposal has been accepted.
- Chief Crowell stated that the current body cameras were no longer serviceable, and the Town Board funded a new body camera program.
- Chief Crowell stated that calls for service are up.
- Chief Crowell discussed a new legislative change that will allow local judges to sign search warrants for people who have been issued an order of protection.
- Chief Crowell stated that the retention survey will be taking place soon.

Member Schepp stated that the Village of Minoa has experienced an increase in speeding.

Member Nicholson stated that the residents of the Ravine Ridge Neighborhood are requesting a left-hand turn lane on Highbridge Road.
