On July 6, 2017 hydrant flow test was conducted at Hoag Lane in the town of Manlius, NY. All testing was performed in accordance with NFPA 291 standards.

Hydrant #4117 was flowed at a rate of 798 gallons per minute (gpm). The static pressure at Hydrant 4115 was measured at 62 pounds per square inch (psi) at the start of the test and a residual pressure of 51psi during the test. Based on this test, the calculated system capacity at the hydrant is approximately 1,644 gpm at 20psi residual pressure, under similar conditions. Please review all mapping and documentation included in this report. OCWA's records indicate the water main in this area is 10" diameter pipe.
