WHEREAS, the Town Board has been working with the residents of the Skyridge Water District to improve the water quality in the District and the expand the District to include the Clear Path for Veteran's property;

WHEREAS, the New York State created the Water Quality Improvement Project Program (WQIP) which provides funding to protect sources of public drinking water by funding land acquisition;

WHEREAS, the State requires municipalities or water districts applying for the WQIP to match the grant of 25% of the grant amount received;

WHEREAS, eligible project costs include: buying land or development rights; transactional costs such as surveys, appraisals, transfer taxes, and title reports; and riparian buffer or wetland restoration costs.

NOW, THEREFORE BE IT RESOLVED, that Town Board hereby authorizes the Supervisor to make application to the Water Quality Improvement Program in the amount of up to \$550,000.00 to offset the cost of the Skyridge Water District to acquire land and/or conservation easements to protect the recharge areas for their drinking water wells.
