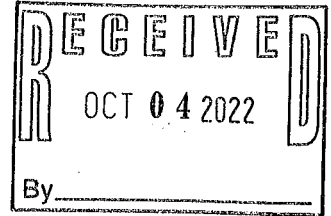

- D. A person who knowingly and intentionally violates this section shall be guilty of a misdemeanor.
